Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

- Move from head office premises to carbon neutral location thus bringing head office emissions to zero.
- Reduce commuter car usage by 25% by introducing cycle to work scheme.
- Purchase a ten acre forest in the UK to offset carbon emissions by 50%.

We project that carbon emissions will decrease over the next five years to 0 tCO2e by 2025. This is a reduction of 100%

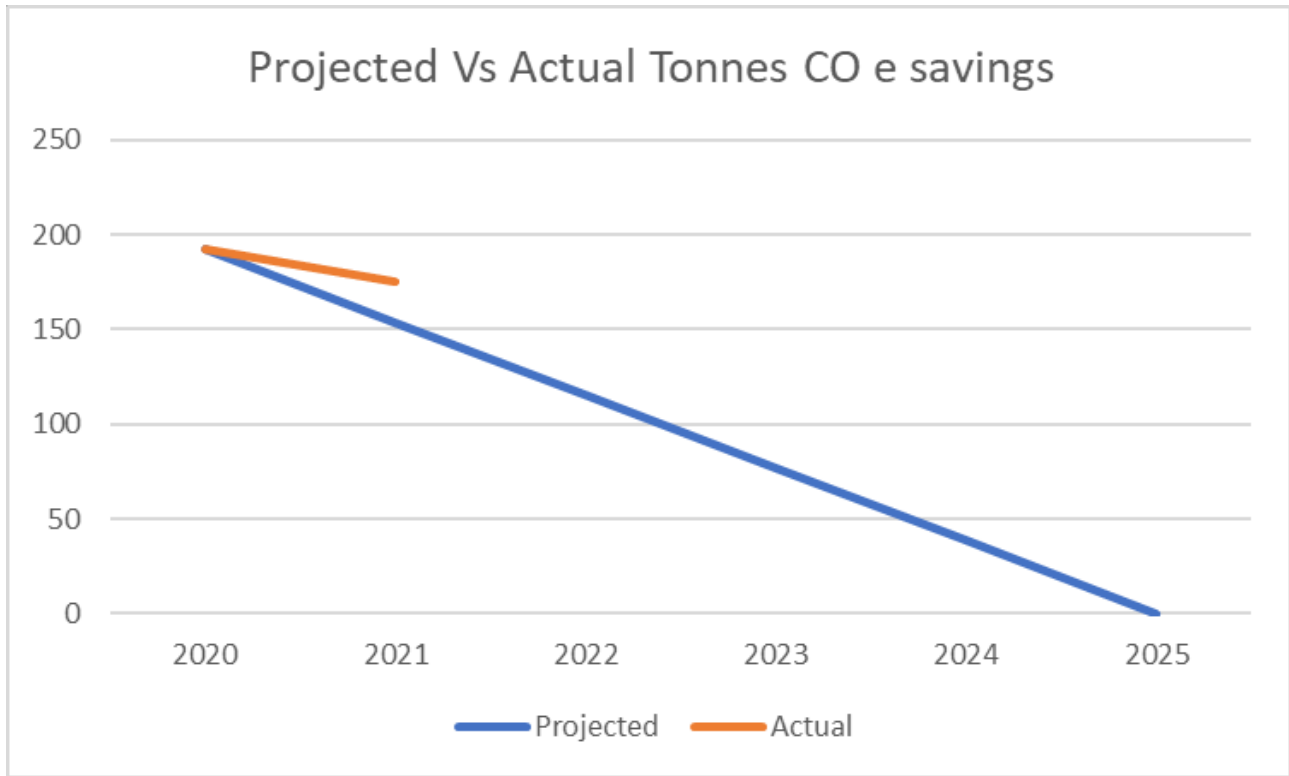

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2020 baseline. The carbon emission reduction achieved by these schemes equate to 16.9 tCO₂e, a 8.8% reduction against the 2020 baseline and the measures will be in effect when performing the contract

- Reduction in usage of Head Office



- Reduction in international business travel

In the future we hope to implement further measures such as:

- Move head office to a carbon neutral location
- Introduce cycle to work scheme to reduce car usage
